安全注意事項

電動工具一般安全注意事項

警告

請詳讀工作臺及電動工具的所有安全警告與使用說明。若不

遵照以下列出的指示，將可能導致電擊、著火和 / 或人員重傷。

保存所有警告和說明書以備查閱。

在所有警告中，「電動工具」此一名詞泛指：以市電驅動的（有線）電動工具或是以電池驅動的（無線）電動工具。

工作場地的安全

- ▶ 保持工作場地清潔和明亮。混亂和黑暗的場地會引發事故。
- ▶ 不要在易爆環境，如有易燃液體、氣體或粉塵的環境下操作電動工具。電動工具產生的火花會點燃粉塵或氣體。
- ▶ 讓兒童和旁觀者離開後操作電動工具。注意力不集中會使您失去對工具的控制。

電氣安全

- ▶ 不得將電動工具暴露在雨中或潮濕環境中。水進入電動工具將增加電擊危險。

人身安全

- ▶ 保持警覺，當操作電動工具時關注所從事的操作並保持清醒。當您感到疲倦，或在有藥物、酒精或治療反應時，不要操作電動工具。在操作電動工具時瞬間的疏忽會導致嚴重人身傷害。
- ▶ 使用個人防護裝置。始終佩戴護目鏡。安全裝置，諸如適當條件下使用防塵面具、防滑安全鞋、安全帽、聽力防護等裝置能減少人身傷害。
- ▶ 防止意外起動。確保開關在連接電源和 / 或電池盒、拿起或搬運工具時處於關閉位置。手指放在已接通電源的開關上或開關處於接通時插入插頭可能會導致危險。

- ▶ 手不要伸展得太長。時刻注意立足點和身體平衡。這樣在意外情況下能很好地控制電動工具。
- ▶ 著裝適當。不要穿寬鬆衣服或佩戴飾品。讓您的衣物及頭髮遠離運動部件。寬鬆衣服、佩飾或長髮可能會捲入運動部件中。
- ▶ 如果提供了與排屑、集塵設備連接用的裝置，要確保他們連接完好且使用得當。使用這些裝置可減少塵屑引起的危險。
- ▶ 切勿因經常使用工具所累積的熟練感而過度自信，輕忽工具的安全守則。任何一個魯莽的舉動都可能瞬間造成人員重傷。

電動工具使用和注意事項

- ▶ 不要濫用電動工具，根據用途使用適當的電動工具。選用適當設計的電動工具會使您工作更有效、更安全。
- ▶ 如果開關不能開啟或關閉工具電源，則不能使用該電動工具。不能用開關來控制的電動工具是危險的且必須進行修理。
- ▶ 在進行任何調整、更換配件或貯存電動工具之前，必須從電源上拔掉插頭並 / 或取出電池盒。這種防護性措施將減少工具意外起動的危險。
- ▶ 將閒置不用的電動工具貯存在兒童所及範圍之外，並且不要讓不熟悉電動工具或對這些說明不瞭解的人操作電動工具。電動工具在未經培訓的用戶手中是危險的。
- ▶ 保養電動工具與配備。檢查運動件是否調整到位或卡住，檢查零件破損情況和影響電動工具運行的其他狀況。如有損壞，電動工具應在使用前修理好。許多事故由維護不良的電動工具引發。

電池式工具使用和注意事項

- ▶ 只用製造商規定的充電器充電。將適用於某種電池盒的充電器用到其他電池盒時會發生著火危險。
- ▶ 只有在配有專用電池盒的情況下才使用電動工具。使用其他電池盒會發生損壞和著火危險。
- ▶ 當電池盒不用時，將它遠離其他金屬物體，例如回形針、硬幣、鑰匙、釘子、螺絲或其他小金屬物體，以防一端與另一端連接。電池端部短路會引起燃燒或火災。
- ▶ 在濫用條件下，液體會從電池中濺出；避免接觸。如果意外碰到了，用水沖洗。如果液體碰到了眼睛，還要尋求醫療幫助。從電池中濺出的液體會發生腐蝕或燃燒。
- ▶ 請勿使用已受損或經改裝的電池盒。已受損或經改裝的電池組可能出現無法預期的反應，進而導致著火、爆炸或造成人員受傷。
- ▶ 勿讓電池盒或工具靠近火源或暴露於異常溫度環境中。若是靠近火源或暴露在超過 130 °C 的環境中可能造成爆炸。

檢修

鑽孔的安全警告

所有作業的安全說明

使用長鑽頭的安全說明

為充電電池進行充電

► **只能選用技術性數據裡所列出的充電器。**僅有這些充電器適用於電動工具所使用的鋰離子充電電池。

提示：由於國際運輸規定，出貨時鋰離子充電電池已部分充電。初次使用電動工具之前，請先將充電電池充飽電以確保充電電池蓄滿電力。

安裝充電電池

將已充飽電的充電電池推至充電電池固定座內，直到卡緊。

取出充電電池

若要取出充電電池，請按解鎖鈕，然後將充電電池抽出。**不可以強行拉出充電電池。**

如何正確地使用充電電池

妥善保護充電電池，避免濕氣和水分滲入。

充電電池必須儲存在 –20 °C 至 50 °C 的環境中。夏天不可以把充電電池擱置在汽車中。

偶爾用柔軟、乾淨且乾燥的毛刷清潔充電電池的通氣孔。

充電後如果充電電池的使用時間明顯縮短，代表充電電池已經損壞，必須更換新的充電電池。

請您遵照廢棄物處理相關指示。

安裝

► **在電動工具上進行任何作業之前 (例如維修，更換工具等等)，請將機器中的電池取出。**若是小心觸動起停開關，可能造成人員受傷。

► **更換工具時請戴上防護手套。**長時間操作之後，嵌件工具和鑽夾頭溫度會變高。

更換工具 (請參考圖 A)

調整旋轉方向 (請參考圖 B)

預設扭力

使用預設扭力調整環 (3)，您可以分段預選所需的扭力。如果設定了合適的扭力，當螺栓在物料中一旋入至表面齊平後，或者說到達所設扭力之後，嵌件

工具便會停止轉動。在位置 ，過載離合器被停用，例如用於鑽孔或鎖入大型螺栓。在此段位可達到最大扭力。
